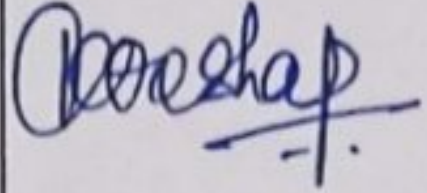
II. AIMS AND OBJECTIVES: -

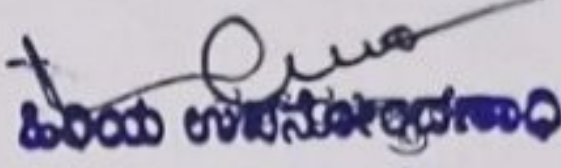
The aims and object of the trust shall be charitable in nature as envisaged in section 2 (15) of Income Tax Act 1961 which include: -

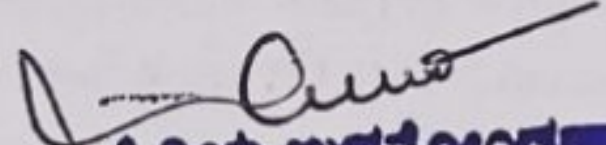

- 4) Any question arising on the administration of the trust shall be decided in trust.
- 5) The trustees make out corpus of the subject matter of the trust spend such money or appropriate such money for laying out, erecting and furnishing any building, structures, premises research institutes or for incurring such other capital expenditure as may be unanimously resolved by the trustees.

The treasurer along with the Chairman hereby authorized to operate all such accounts jointly for and on behalf of the trust as may be decided by board of trustees from time to time.
- 10) It shall be competent for the trustees from time to time to constitute, frame, make and enforce all such rules and regulatons, bylaws which are not inconsistent with the expression, provisions of this trust as trustees deem proper for securing and facilitating th administration and management of the various activities and affairs of the trust and for convening, conducting and regulating the meetings and of appointing committees, sub-committees and generally for the management and administration of the trust properties and also from time to time to repeal, alter, amend, rescind or add to all such rules and regulations and bylaws and also to pass resolutions in connection with all or any of the said matter at their meeting.
- 11) It is hereby expressly declared that the trust hereby created is irrevocable.
- 12) Every power, authority or discretion herein above or hereafter conferred upon the trustees shall be exercised or signified either by some instrument in writing to be signed by all the trustees or by resolutions of a majority who shall be present and vote at a meeting of the trustees provided that
